Subject: **Budget Adjustment due to increased Consolidated Highway Improvement Program (CHIPS) funding, Extreme Winter Recovery, and PAVE NY Apportionments - Highway Department**

The subject item is being submitted to the Facilities & Infrastructure committee for review and approval. This item will require approval by the Legislature. Pertinent information is as follows:

**1. Action requested:**

Committee authorization is sought to approve the acceptance of increased revenue and transfer of the increase into an expense account.

**2. Background:**

New York State has increased the Consolidated Highway Improvement Program (CHIPS), Extreme Winter Recovery, and PAVE NY Apportionments for Tompkins County \$292,272.70 over the 2016 reimbursement.

The resolution seeks the funds to be transferred to the highway materials budget account.

**3. Financial Implications:**

This increase will allow Tompkins County Highway to perform additional road repair and/or reconstruction projects in 2017.
