1. Action requested:

Committee authorization is required for the County to execute a contract to design replacement of the bridge carrying Dodge Road over Cascadilla Creek in the Town of Dryden.

2

2. Background:

Since 2001 the New York State County Highway Superintendent's Association, in conjunction with the New York State Department of Transportation, has developed multi-year term lists for use by municipalities in selecting consultants for highway and bridge projects in all NYSDOT regions of the state. The 15-firm list designated for the period from 2016 to 2019 for the region of which Tompkins County is a part includes:

- Bergmann Associates (Rochester)
- Bryant Associates (Syracuse)

The Highway Department evaluated qualification statements from the listed firms for two ongoing federal-aid bridge projects considering: 1) staff experience and qualifications; 2) firm experience; 3) familiarity with the County; and 4) the firm's general technical and professional competence. Based on that evaluation, the Highway Department recommended a consultant for the Dodge Road Bridge project from the list as well, Barton and Loguidice (B&L).

This resolution authorizes a contract with B&L for design and, if warranted, construction support services. B&L has worked with the Highway Department on many bridge and highway projects in the past several years.

Dodge Road is a rural local road with an average traffic volume of 80 vehicles per day in 2007. The bridge is a 32-foot span multi-girder structure built in 1935. It is 18-feet wide, which is significantly less than the 28-feet

standards recommend for a road of its traffic volume and functional classification. In 2015 the bridge had a condition rating of 3.6, which indicates significant deterioration. It is considered scour critical, meaning its foundations could be unstable in flood conditions. NYSDOT has deemed it not eligible for historic registration. Bridge replacement construction is scheduled for 2018.

3. Financial Implications:

The recommended contract is for \$77,300, well within the budgeted design cost of \$130,000. Since this is a town road, the County anticipates 20% of the costs to be the Town of Dryden. The County is responsible for initially paying all costs.
