3            WHEREAS, the Governor of the State of New York awarded \$1,436,655 in Public Transportation  
4 Modernization & Enhancement Program funding for capital projects in Tompkins County, and

6            WHEREAS, Tompkins County wishes to apply for the State grant on behalf of Tompkins Consolidated Area  
7 Transit, Inc., to modernize and enhance the public transportation system, and

9            WHEREAS, the \$1,436,655 in New York State funding will reimburse 100% of the costs of proposed projects  
10 as follows:
