5                    WHEREAS, the County has received a grant offer from the New York State Department of Transportation  
6 (NYSDOT) in the amount of \$86,127 to help finance the Rehabilitation of the General Aviation (GA) Apron,  
7 Installation of Perimeter Fencing, and Installation of Apron Flood Lighting at the Ithaca Tompkins Regional Airport,

10                    WHEREAS, the budget for this project will be \$1,722,527 and the financing is as follows:

12 **1. Action requested:**

13  
14 A resolution is being submitted to the Facilities and Infrastructure Committee for review and approval. It also requires  
15 approval by the full Legislature.

17 **2. Background:**

18  
19 The Construction of the GA Apron Rehabilitation, Installation of Perimeter Fencing, and Installation of Apron  
20 Lighting project is being completed by Boland's Excavating. Also covered under this grant is the cost of the  
21 Engineering Inspection, Independent Fee Estimate, and any associated Administrative costs. This grant is the 5% New  
22 York State Department of Transportation (NYSDOT) share in the amount of \$86,127.

24 **3. Financial Implications:**

26 In addition to the NYSDOT grant of \$86,127 (5%) the airport will receive a FAA grant of \$1,550,274 (90%). The local  
27 share of \$86,126 (5%) will be paid for by accumulated Passenger Facility Charge (PFC) revenues and will not impact  
28 the airport's operational budget or the County tax payers once the PFC application has been finalized, total project cost  
29 \$1,722,527.
