2 Explanation: This resolution outlines the Office for the Aging's intention to utilize Foodnet Meals on Wheels as its
3 subcontractor for all components of Tompkins County's nutrition program for the next ten-year period. COFA has
4 enacted ten-year contracts with Foodnet in the past because it offers stability for both parties in implementing a very
5 complex program serving frail and vulnerable clients. While the ten-year contracts state COFA's intention to work
6 with Foodnet over this period, amendments and budgeted amounts are updated and signed annually through
7 agreement, and are contingent on the availability of Federal, State and County funds. This does not obligate the
8 County to reimburse Foodnet a fixed budgeted amount over that ten-year period.
