1 **Amendment of the 2018 Tompkins County Budget to Reflect**
2 **Appropriation of 2018-2019 Budgets for the Ithaca-Tompkins County**
3 **Transportation Council and Authorization to Implement the**
4 **Amendment (Pending Committee action 4-3-18)**

5 WHEREAS, Tompkins County serves as the Host Agency for the Ithaca-Tompkins County Transportation
6 Council, the Metropolitan Planning Organization for the Ithaca-Tompkins County area, and

8 WHEREAS, the County has a contract with the New York State Department of Transportation to provide funding
9 for the Ithaca-Tompkins County Transportation Council through grants provided by the Federal Highway Administration
10 and Federal Transit Administration, and

12 WHEREAS, the Ithaca-Tompkins County Transportation Council has grant authorizations for its 2018 -2019
13 fiscal year, beginning April 1, 2018, and ending March 31, 2019, in the amounts of \$293,691 from the Federal Highway
14 Administration (FHWA), and \$40,991 from the Federal Transit Administration (FTA), and

16 WHEREAS, the Policy Committee of the Ithaca-Tompkins County Transportation Council has adopted resolution
17 2018-01, *APPROVAL OF THE 2018-2019 ITHACA-TOMPKINS COUNTY TRANSPORTATION COUNCIL*
18 *OPERATING BUDGET*, which requests that the Host Agency (Tompkins County) take the appropriate actions to fully
19 implement said operating budget, now therefore be it

21 RESOLVED, on recommendation of the Planning, Development, and Environmental Quality Committee, That the
22 budgets for the Ithaca-Tompkins County Transportation Council, as presented in "ATTACHMENT A" to this resolution,
23 be amended in the 2018 Tompkins County budget and that the County Finance Director be authorized to expend such
24 funds for the period from April 1, 2018, through March 31, 2019.

2 The Ithaca-Tompkins County Transportation Council (ITCTC) receives its budget as grant authorizations from federal
3 highway (FHWA) and federal transit (FTA) every year; its fiscal year is 4/1 - 3/31. For the fiscal year of April 1, 2018
4 - March 31, 2019 the ITCTC is receiving \$293,691 FHWA and \$40,991 FTA funds. The ITCTC Planning and Policy
5 Committees have reviewed and approved this operating budget. There is zero impact on the budget of Tompkins
6 County. The approval of this resolution grants the authority to amend the 2018 Tompkins County budget to include
7 the ITCTC 18-19 budget and authorizes the County Finance Director to allow the expenditure of these funds by the
8 ITCTC.
